**Sub: Implementation of works under Jal Jeevan Mission (JJM).**

Ref: Video Conferencing (VC) held on 25.06.2020 with the officials of DDWS, MoJS, Gol.


Dear sir,

We are thankful for clarifying various issues related to the implementation of JJM and now we are moving ahead with the following understanding based on clarification given by Gol officials on JJM guideleines during the above referred VC:

1. Ongoing/Retrofitting schemes are to be retrofitted for 100% FHTC and works can immidiately be started without waiting for deployment of ISA/TPI and preparing VAP.
2. Administrative Approval of Retrofitting/new schemes can be accorded by the Departmental competent authorities till the powers are delegated to DWSM.
3. Tenders for works can also be invited/approved on EPC mode as per prevailing departmental procedures. Various works can be clubed to minimise the number of contracts agreements which will help in execution of works.
4. Public contribution in retrofitting works can be collected by VWSC at later stage for maintenance of schemes.
5. Life cycle of SVS has to be kept 20years and accordingly the various components of the schemes should be designed. To expedite the designing of retrofitting/new schemes, we are following guidelines given in "Manual for Preparation of Detailed Project Report for Rural Piped Water Supply Schemes" issued by MoDWS, Gol vide F. No. W-11011/01/2012/W-I dt 20.02.2013 with the provision of 55LPCD potable water to be supplied through FHTC at doorstep of households as per JJM guidelines. Clarification on design criterias of SVM/MVS will be given by Gol in light of JJM, if required.


We are glad to inform that our State has achieved the target of 1.81 Lakh FHTC set for first quarter prior to its completion. Under able guidance of Gol officials and with the above clarifications, we are confident that our State will achieve the yealy target too.

We also request to your goodself to issue the revised "Manual for Preparation of Detailed Project Report for Rural Piped Water Supply Schemes" issued by MoDWS, Gol vide F. No. W-11011/01/2012/W-I dt 20.02.2013 incorporating the norms of JJM to have uniformity in the preparation of DPRs and design of the schemes across the country.
